VISA REQUIREMENTS CHECKLIST (29 SCHENGEN COUNTRIES)

1. Mandatory Documents

- Valid Passport (minimum 6 months validity from departure date, with at least 2 blank pages)
- Original Bank Statements for the last 6 months (duly stamped and signed by the bank)
- Mandatory Travel Medical Insurance (minimum coverage of €30,000 covering all 29 Schengen states)
- Recent Visa Photographs (35 × 45 mm, 70–80% face coverage, white background, matte finish)
- Employment Proof: No Objection Certificate (NOC) & recent 3 months payslips from employer (if employed)
- Income Tax Returns (ITR / Tax Assessment Notices) - if filed
- For Self-Employed Applicants: Business registration (e.g., partnership deed, company registration / ABN, company tax returns)
- Invitation Letter from a Schengen company (Business) or Family/Friend in Schengen (Family visit)

2. Supporting Documents (Optional)

- Property and real estate ownership documents
- Credit card statements & Fixed deposit certificates
- Asset evaluation reports proving financial stability
- Documentary proof of strong family ties in home country

Processing Timelines

Holidaypanda.au Turnaround: 2 to 3 working days for application preparation and document compilation from receipt of complete information.

Embassy / Consulate Processing: Typically **15 to 20 working days** from the appointment date, subject to variation based on the destination country and consulate workload.

Note: Processing timelines may extend during peak holiday seasons (summer and year-end). Applicants are advised to apply at least 4–6 weeks prior to intended departure.

Fee Details & Conditions

Schengen Embassy / Consular Fee: €90 Euro (payable directly at the Visa Application Centre / Consulate).
