VISA REQUIREMENTS CHECKLIST

1. Mandatory Documents

- Valid Passport (minimum 6 months validity, colour copy of all pages)
- Original Bank Statements for the last 3 to 6 months (duly stamped & signed)
- Employment Proof: NOC / Salary Certificate & recent 3 months payslips (if employed)
- Income Tax Return (ITR / Tax Assessment Notices) - if filed
- For Self-Employed: Business registration (Partnership deed, Company License / ABN), Company Tax Returns
- Invitation Letter from a UK-based company (Business) or Family/Friend in UK (Visit)

2. Supporting Documents (Optional)

- Property and real estate deeds / valuation certificates
- Credit card statements & Fixed deposit certificates
- Proof of Investments (Shares, Mutual Funds, Life Insurance policies)
- Proof of Family Ties & Vehicle Registration (RC)

3. Invitee / Sponsor Documents

- Formal Invitation Letter / Sponsorship Letter
- Invitee / Sponsor ID & Passport Copy
- UK Residence Permit / BRP / UK Visa status copy
- Sponsor Bank Statements (6 months) & Payslips (3 months)
- UK Rental Agreement / Utility Bills / Proof of Accommodation

4. Validity & Processing Timelines

Holidaypanda Processing: 2 to 3 working days upon receipt of complete documents.

British Embassy / UKVI Processing: Typically **15 to 20 working days** post-biometrics.

UKVI also offers Priority and Super Priority processing services at additional cost.

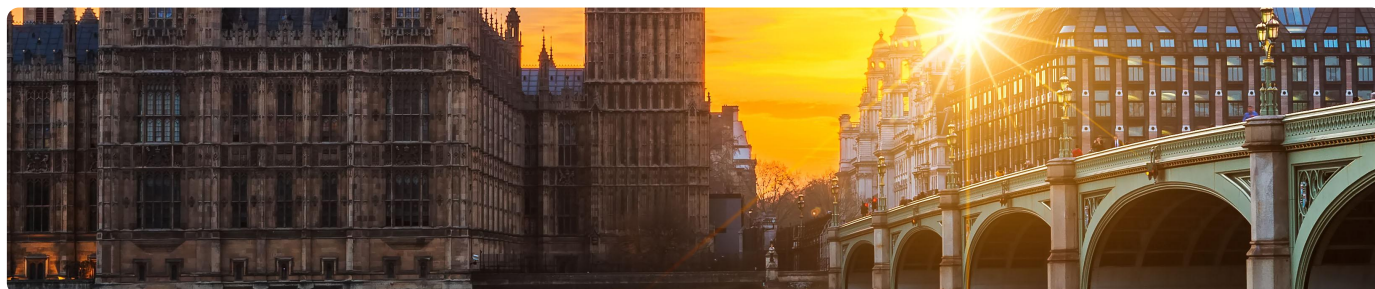

Visa Validity & Conditions

The validity of a UK visa depends on the category selected (6 Months, 2 Years, 5 Years, or 10 Years). The duration and validity are determined solely by the UK Home Office / UKVI.

Note: A longer-validity visa permits multiple visits up to 6 months per entry and does not permit continuous stay. Official visa fees are non-refundable once submitted.
